Towson University College of Business and Economics Policy Statement on Faculty Qualifications April 2019

Scholarly Academic (SA)

A CBE faculty member is deemed to be a scholarly academic if he or she meets one of the following criteria:

- 1. Faculty members who have earned an appropriate doctorate during the most recent fiveyear period are considered a scholarly academic.
- 2. A faculty member holds a doctorate degree in a business field, but primary teaching responsibility in a business field that is not the area of academic preparation. The faculty must maintain active involvement in the areas of teaching responsibility through writing, participation in professional meetings, or related activities.
- 3. Faculty members who have officially achieved ABD status are considered a scholarly academic for a period of three years from the time they were designated ABD.
- 4. A doctoral degree outside of business, but primary teaching responsibilities that incorporate the area of academic preparation. The faculty must maintain active involvement in the areas of teaching responsibility through writing, participation in professional meetings, or related activities.
- 5. The faculty member holds an appropriate doctorate degree in the area in which she or he teaches, or JD degree or M.S. in taxation for those teaching business law/legal or accounting tax classes, respectively.

To maintain the scholarly academic qualification, a faculty member should:

Publish at least two (2) scholarly, peer reviewed journal articles related to the college mission supplemented, if necessary, by activities from the various sources of intellectual contributions listed in the academic engagement table during the most recent 5 year period to secure a total of at least 18 points. See table at end.

Practice Academic (PA)

A CBE faculty member is deemed to be a practice academic if he or she meets one of the following criteria:

- 1. A faculty member holds a doctorate degree in a business field, but primary teaching responsibility in a business field that is not the area of academic preparation. The faculty must maintain active involvement in the areas of teaching responsibility through writing, participation in professional meetings, or related activities.
- 2. A doctoral degree outside of business, but primary teaching responsibilities that incorporate the area of academic preparation. The faculty must maintain active involvement in the areas of teaching responsibility through writing, participation in professional meetings, or related activities.

- 3. Individuals with a graduate degree in law will be considered PA for teaching business law and legal environment of business, subject to ongoing, sustained, and substantive academic and/or professional engagement activities demonstrating currency and relevance related to the teaching field.
- 4. Individuals with a graduate degree in taxation or an appropriate combination of graduate degrees in law and accounting will be considered PA for teaching tax accounting, subject to ongoing, sustained, and substantive academic and/or professional engagement activities demonstrating currency and relevance related to the teaching field.

To maintain the practice academic, a faculty member should:

Complete activities from the various sources of intellectual contributions listed in the academic engagement table and those items listed in the professional engagement table during the most recent 5 year period to secure a total of at least 11 points. See tables at end.

Scholarly Practitioner (SP)

- 1. The faculty member holds an *appropriate master's degree or higher* in a field related to the teaching discipline.
- 2. The faculty member has *practical work experience* that is relevant to the teaching area, and significant in duration, currency and level of responsibility, at the time of hiring (up to five years after hire).

To maintain scholarly practitioner qualification, a faculty member should:

Publish at least one (1) scholarly, peer reviewed journal article(s) related to the college mission and complete activities from the various sources of intellectual contributions listed in the academic engagement table and those items listed in the professional engagement table during the most recent 5 year period to secure a total of at least 11 points. See tables at end.

Instructional Practitioner (IP)

- 1. The faculty member holds an *appropriate master's degree or higher* in a field related to the teaching discipline. In some limited cases, a faculty member without a master's degree in the field related to teaching or without a master's degree can be considered if the professional experience at the time of hiring is of such depth, duration, sophistication, and complexity, the lack of a master's degree in the field of teaching is overcome.
- 2. The faculty member has *practical work experience* that is relevant to the teaching area and significant in duration, currency and level of responsibility, at the time of hiring (up to five years after hire).

To maintain Instructional Practitioner qualification, a faculty member should:

Show evidence of continuous learning during the most recent five-year period. They can demonstrate continuing currency by engaging in at least three (3) professional activities listed in the professional engagement table, at least one of which must be associated with maintaining their knowledge in the field.

Part-time faculty members who remain employed in their area of expertise are deemed to be maintaining currency. Part-time faculty, no longer in the workforce, and full-time faculty who are deemed instructional practitioners, must maintain currency in their field as well as in the pedagogical area.

Administrative Roles: In accordance with AACSB policy, faculty who serve in key administrative capacities (e.g., dean, associate or assistant dean, chair), and are teaching, are deemed professional academic (PA) unless during their administrative tenure, they maintain their SA status. In addition, they shall be classified as participating faculty. They maintain their qualifications by participating in activities that are related to their administrative roles and responsibilities, or through scholarship, or a combination of both.

Upon the returning to the faculty, the following standards apply:

- An administrator who returns to a department in compliance with the scholarly academic standards shall be SA.
- An administrator who returns to a department shall be deemed PA for two years unless they
 maintain their SA status. By the third year, the former administrator must have published
 one quality peer-reviewed journal article to remain PA. By the fifth year, the former
 administrator is expected to achieve the standards for SA.
