  - Lighting Designer
  - Sound Designer
  - Dramaturg
  - Stage Manager

### Production

- Technical Director
- Costumière
- Music in a non-musical, if applicable
- Dialogue Coach, if applicable
- Movement Coach, if applicable
- All "assistant" positions in the same order as above
- The rest of the production staff in alphabetical order
- All crews

#### Other information to be included:

- Director's notes, if applicable
- Description of locale, time period, scenes, songs, acts, intermissions, if appropriate
- List of theatre faculty and staff in alphabetical order
- List of names and dates of all future Mainstage and Studio Department of Theatre Arts productions, and the next event from each of the other
